PPERRIA Membership and Board of Directors Meeting Monday, January 22, 2007, 7:15 p.m. PPUMC

- 1. President Susan Joe Ring called the meeting of the Association to order at 7:15 p.m.
- 2. A motion to approve the agenda, as corrected, was made by Dick Poppele. Passed without noes.
- 3. The minutes were not approved as the newsletter did not reach members prior to the meeting.
- 4. **Announcements:** Volunteers are needed to provide the pre-meeting refreshments.

The annual East River Gorge cleanup will take place on April 21. Volunteers are needed.

- Release of NRP Funds: Mary Alice Kopf moved to release \$35,000 to SWIM (Somali Women in Minnesota) for a program to prepare Somalis for home ownership. Passed. Mary Alice Kopf moved to release \$14,000 to Southeast Seniors to provide services allowing seniors to stay in their homes.
- 6. **SAAG Report:** Dick Poppele reported on the completion of the report to the legislature prepared by the Stadium Area Advisory Group mandated by the legislation approving a University of Minnesota football stadium. Dick described the process used by the group in preparing the report, and summarized its recommendations, which include:
 - (1) Continue the good work already underway.

(2) Initiate organizational steps to create a new alliance that brings together the University, the City, and the neighborhoods and empowers them to act collaboratively. Provide start-up funds to begin this work immediately (\$500,000).

(3) Take immediate action on first priority initiatives (Phase I) needed to reverse the neighborhood decline. Provide an initial capital grant to begin this work in 2007 (\$5,000,000).

(4) Capitalize an endowment to provide sustained funding for alliance activities, including development of a long-term plan (\$20,000,000).

(5) Provide additional endowment funds, to be matched by alliance fundraising, to implement Phse II project arising out of long term plan.

The complete report is available on the pperr.org website. The report will be presented to the Intergovernmental Relations committee of the Minneapolis City Council on Jan. 23, and to the City Council on Friday January 26. Councilman Cam Gordon wants neighborhood approval before he gives his support to the report. Dick Poppele moved approval of a resolution: Prospect Park and East River Road Improvement Association (PPERRIA) endorses the report on the impact of the University of Minnesota on neighborhoods ("Moving Forward Together") and fully supports the recommendations it makes to the State Legislature. The report enumerates many issues and action plans that have been part of the PPERRIA agenda for many decades." Passed with one abstention.

Dick reported that in conjunction with the report the City of Minneapolis had already endorsed an inspections sweep of rental properties in the Marcy-Holmes and Como neighborhoods.

7. Sound Wall Resolution: Dorothy Davey moved approval of a resolution: Be it resolved that Prospect Park East River Road Improvement Association endorses and actively supports public financing and construction of an extension of the existing sound wall (or some other form of freeway noise abatement equally or more effective) from the northwest corner of East River Mews eastward on a line nortyh of East River Terrace as far as Cecil St. SE. PPERRIA will, on behalf of the residents of East River Terrace and East River Mews, notify public officials including State Representative, State Senator, Hennepin County Commissioner, May of Minneapolis and Second Ward Councilman of its support. PPERRIA will provide advice and lend strategic assistance to the residents of East River News and East River Terrace in the pursuit of their objective. Approved without noes.

9. Livability Report:

Crime: Joe Ring reported a 2% drop in crimes in the area from 2005. All of the student housing projects have the same company providing security for their properties.

Conditions: The St. Anthony Park District Council has developed a set of conditions to attach to the development of the student housing project proposed by JPI. Joe Ring requested that the Zoning and Livability Committees review those conditions with a goal of attaching conditions to new projects proposed in the area.

- 8. Community Engagement Report: Florence Littman reported that final comments were due to the City of Minneapolis on its Community Engagement Report on February 8. A questionnaire is on the City's website, and is available at Schneider's Drug. Residents are urged to complete. A meeting will be held at Marcy School on January 31. Florence's main concern is to change the city's policy of administrative review of certain requests for approval of plans.
- 9. Zoning Report: The Stadium Village Plaza (site of former Blockbuster) which has requested an additional parking variance, has agreed to the conditions that PPERRIA requested. Citgo: The planning Commission rejected the plan for reconstruction of the Citgo filling station at University and 25th Ave SE, denying all of the requested variances. The owner has not decided whether to appeal. Dick Poppele moved that we send a letter of support if the owners decide to appeal. Approved without noes.

M Flats: The Planning Commission approved the revised plan for 44 units of student housing at University and Arthur Ave. SE.

A motion to adjourn by Tom Davey was passed without noes.
