Notes from the President

Tt is budget time again as we prepare for PPERRIA's annual meeting in April. You may recall that we recently received *Citizen Participation Program* funds from the Minneapolis Department of Neighborhood and Community Relations (NCR).

It's about \$40,000 per year, and it replaces staff support funding we were getting from NRP (which no longer exists), as well as new program funding we used in hiring neighborhood consultants. [Steve Cross (PPERRIA past president) reestablished neighborhood block clubs, and Jim Widder firmed up relationships with neighborhood businesses.] The funding also supported the Prospect Park 2020 project, PPERRIA's effort to shape new development in the area along our section of the light rail corridor.

The City tells us this funding will continue as 3-year block grants. Nevertheless we can't depend on it since, as a new City program, it could change in coming years.

And that brings us to the PPERRIA budget. Income has traditionally been both from member donations and City support. The split had been about 60% donations and 40% City. This year it was closer to 15% and 85% respectively.

This means that residents and businesses now have relatively less invested in our neighborhood destiny.

Grant funds (City) primarily support ongoing tasks. They do not allow for building reserve funds for unexpected situations. For example, the recently constructed sound wall on I-94 has caused serious problems for residents. PPERRIA will likely incur major expenses in getting any fair mediation.

We will address this issue at the PPERRIA Annual Meeting on April 23rd, where we will announce the kick-off of a *Neighborhood Investment Fund* to raise the money for building a reserve fund. The goal is to give us the resources for realizing our long-term vision for the neighborhood. This fund will allow us to have "skin in the game," and not simply be the victim of outside forces.

We have seen this principle at play in this year's efforts at directing development around the Prospect Park LRT station. The Prospect Park 2020 project got \$60,000 in funding for hiring consultants and for playing a proactive role because PPERRIA put up \$5000 from its reserve funds as a part of the grant application. Here's an example of how reserve funds can be leveraged – and it has worked:

- As a direct result of PPERRIA's efforts, the Textile Center elected not only to stay in the neighborhood, but also to undertake a major expansion in the station area.
- Cornerstone Developers, who share PPERRIA's vision for new development, recently acquired control of a major site next to the new station.

Prospect Park has a reputation for being a great place to live – for being an active neighborhood that works together to make a difference. PPERRIA has been effective over the years solely as a volunteer organization. Today, however, situations tend to evolve quickly and with more complexity. It is now more than ever necessary to rely on professional consultants for defining neighborhood interests and for advocating to local government and developers. Short of setting up a PPERRIA office with a regular staff, we must give our volunteer organization of committees and task groups the capacity to employ professional help when it is needed.

The *Neighborhood Investment Fund* will be a 2- or 3-year campaign to raise a significant reserve fund. It will offer opportunities to invest through both pledges and donations. The emphasis will be on participation – at every level – to attain maximum buy-in from residents and businesses for the sake of our future.

PPERRIA Meeting Minutes for February 27, 2012, Prospect Park United Methodist Church

HIGHLIGHTS:

- Senator Kari Dziedzic gives update on I-94 sound wall
- Update on Light Rail construction along University Avenue
- Walkability Survey distributed
- Board votes to oppose State marriage amendment

The monthly meeting of the Prospect Park-East River Road Improvement Association was called to order by President Dick Poppele at 7:04 PM. He thanked Betts Zerby for providing brownies, cookies and fruit for refreshments.

Guests in attendance included Aaron DuBois (*The Minnesota Daily*), Jay Gabler (*Twin Cities Daily Planet*), Anne White (District Councils Collaborative), and Kari Dziedzic (our new state senator).

A quorum of the Board of Directors was present. Unless otherwise noted, a separate Board vote was not taken on issues on which the membership voted. Unanimous votes of the membership can be considered a vote of the full Board of Directors when a quorum of the Board is present.

The agenda was approved as published.

The minutes of the January meeting were approved with one spelling change.

The Treasurer's report was approved.

UPDATE ON SOUND WALL

Kari Dziedzic, our new state senator from Senate District 59, introduced herself. She won office in a January special election to replace Larry Pogemiller. Dziedzic said she sits on Senate committees on the environment and jobs/economic development and on a subcommittee on government reform. In response to neighborhood complaints that the new sound wall along the south side of Interstate 94 has increased the level of noise in the hill area of Prospect Park, Kari said she has driven and walked along several local sound walls and has traded emails and phone calls to MnDoT on the subject. The State Patrol has monitored speeds along the Prospect Park section of I-94. It is hoped that if traffic speeds can be reduced, the sound level will also be reduced. Some large trucks are down-shifting to avoid using their brakes and this down-shifting of gears is noisy. Kari reported that MnDoT has agreed to send representatives to a meeting with some people from Prospect Park. Bob Sikora volunteered to coordinate this meeting.

ANNOUNCEMENTS

Tom Kilton said the annual Earth Day River Cleanup will be held Saturday, April 21. Volunteers should come to the Franklin Avenue bridge/East River Road intersection at 9:30 AM.

John Orrison said that summer concerts will be held June 20, July 17 and August 14. He said the concert series would be requesting financial support from PPERRIA, as usual.

Jay Gabler, the associate editor of the "Twin Cities Daily Planet," introduced himself. The "Daily Planet" is a non-profit online news source covering the Twin Cities. The link for news of the University district is http://www.tcdailyplanet.net/universitydistrictnews. A free email newsletter covering the University district will be sent out every two weeks. Prospect Park residents are encouraged to subscribe to this service and also to contribute to it. Jay encouraged members to "share what you know about your neighborhood with us." Andy Mickel said there is an icon on the PPERRIA website that goes to the "Daily Planet" website. John Cushing said that several photographers in Prospect Park are each taking one photograph per day in the Park this year.

UDATE ON LIGHT RAIL TRANSIT

Jessica Hill from the Central Corridor Project Office gave a PowerPoint presentation on the schedule for the 2012 construction of the LRT line as it passes through Prospect Park. New construction will begin March 1 unless there is a blizzard before then. Jessica introduced Charlene Zimmer, who works with Ames-McCrosson, the contractor for the Minneapolis side of the LRT line. Most construction on the Central Corridor will be finished in 2012. The year 2013 will see testing and the line will open for passengers in 2014.

Phase 1 of construction will take place on the north side of University Avenue, Phase 2 on the south side. The small parking lot in front of Overflow Coffee will be closed permanently. The parking lot off 4th Street will stay open through construction.

Each business along the Central Corridor has been given an "access map" can be posted on a website and/or handed out in paper form. Gravel paths across construction areas will provide access for businesses and residents. The Construction Hotline is (651) 602-1404. Jessica encouraged PP residents to use this hotline and/or take photos of trucks

that are parked where they shouldn't be during the LRT construction. Jessica's presentation from January is posted on the PPERRIA website and her presentation from tonight's meeting will also be posted there.

During LRT construction the U of M Transit way will be completely repaved and bike traffic encouraged.

MEALS ON WHEELS

Gary Braley of Meals on Wheels left literature on the program. Meals on Wheels is a nation-wide program, with each local community running its own operations. On December 1, 2011, programs in Northeast and Southeast Minneapolis merged. Meals for both neighborhoods are now distributed out of an office at Lowry and Central. About 120 to 160 meals are delivered each day. All drivers are volunteers. Gary encouraged PPERRIA members to encourage their neighbors and friends who are homebound seniors to apply to receive meals by calling (612) 789-6548.

WALKABILITY SURVEY

Phil Anderson, who is PPERRIA's representative to the District Councils Collaborative, said that the DCC started in March 2006 and now includes 13 member neighborhoods in St. Paul and Minneapolis along the Central Corridor LRT line. Its purpose is to facilitate community involvement. One of its achievements has been to get three stations added to the line, at Western, Victoria, and Hamline. The DCC has also advocated for pedestrian-friendly design for the line and the stations. The DCC is now conducting listening sessions for neighbors along the line.

Anne White passed out a draft of a walkability survey which is in the development process. Some of the walking routes to the LRT stations are rather treacherous and the DCC wants to correct this situation. On May 6, the DCC wants to get 100 people to walk to each LRT station in or near Prospect Park (the 29th Avenue station and the Westgate station), in groups, discussing things they see along the route. Such walking-talking groups have been dubbed "Jane's Walks" in honor of Jane Jacobs, the famous urban-planning guru. The DCC hopes that these walks and the surveys will help to set priorities to make repairs and improvements to walking routes to the stations. John Wicks asked if the two cities had committed any money to making improvements. Anne said that they had not yet done so, but both Minneapolis and St. Paul want to get lists of priorities and get people in their communities enthused about walking. John O. asked if copies of the final report would come to the neighborhoods along the line and Anne said they would. John O. said that people of all ages should be encouraged to participate in the survey. John DeWitt said that most of Prospect Park is a very walkable community, but that crossing University Avenue on foot (as will be required for almost all PP residents to get to the stations) is a big problem.

STATEMENT of OPPOSITION TO FEDERAL TRANSIT BILL

At the meeting of the PPERRIA Executive Committee on February 13, the following resolution was passed: "The Prospect Park East River Road Improvement Association strongly opposes the U.S. House Ways and Means Committee proposal to divert \$25 billion in dedicated fuels tax revenues from the Mass Transit Account. This represents nearly 50 percent of the federal investment in public transit authorized by the House surface transportation bill. This drastic change will clearly put public transportation projects at risk. This proposal seeks to undo nearly 30 years of overwhelming bipartisan support for dedicated federal investment in public transit. PPERRIA calls on Congress to continue the long-standing highway and public transit financing partnership in place today so that our country can continue to create American jobs and foster economic growth, as well as rebuild our aging infrastructure and meet the growing demand for improved and expanded transportation." A letter, signed by President Dick Poppele, on behalf of the PPERRIA Executive Committee, was sent to U.S. representative Keith Ellison, urging him to vote against the House proposal.

RESOLUTION on PROPOSED AMENDMENT TO MINNESOTA STATE CONSTITUTION

Steve Cross and Paul Zerby drafted the following resolution regarding the so-called "Marriage Amendment" to the Minnesota Constitution: "Whereas, in November, 2012, the people will vote on a proposal to amend the Minnesota State Constitution to say that: 'Only a union of one man and one woman shall be valid or recognized as a marriage in Minnesota.' And whereas, among the specific purposes of the Prospect Park East River Road Improvement Association (PPERRIA), as stated in its Bylaws, is to promote 'the health, safety and general welfare of the residents within the association's geographic jurisdiction;' And whereas, PPERRIA stands in support of our neighbors, friends and families who would be adversely affected by passage of this change to the Minnesota State Constitution; Now therefore, be it resolved, that PPERRIA opposes the adoption of the proposed constitutional amendment. And be it further resolved, that the President and Secretary of PPERRIA are authorized and directed to send copies of this resolution to whatever individuals and organizations they deem useful in defeating said proposal to amend the Minnesota Constitution."

Dick P. said that a Board vote would be taken on this resolution but the vote would be taken by paper ballot, not by show of hands.

Tom Kilton said he supports PPERRIA's efforts to inform citizens about important issues but that members had only heard one side of this issue. Tony Garmers said that if an issue was sufficiently divisive as to require a secret ballot,

perhaps we should not be involved in it. He said that "amendments to the Constitution are also a lousy way to budget." Paul Z. said that what we are voting on is a clarification of the resolution adopted last month. Karen Murdock read the section of last month's minutes which dealt with the discussion on this amendment. The resolution, which was passed in January by both a membership vote and a Board vote, read as follows: "PPERRIA takes a position opposing the denial of civil rights to gay and lesbian citizens." Lois Willand said that PPERRIA should spend its time discussing things that are clearly neighborhood issues. Steve C. said that the PPERRIA bylaws state that we are concerned with the "general welfare" of neighborhood residents and the proposed marriage amendment affects the welfare of some Prospect Park residents.

Paul Z. said that the PP neighborhood is remarkable and that "there is no place better to live, period." He said that a neighborhood is its people and the people of PP are intelligent, informed, and diverse. He urged the Board to vote in favor of the proposed resolution "out of simple human dignity" and to show that we are a welcoming neighborhood. Betts Z. said she thought this was "an inappropriate thing for the organization to be doing." David Coats said that "we represent the people in the neighborhood" and that many entities in the city, such as churches, are taking stands on the marriage amendment issue. Dick P. said that if Board members felt that the organization should not be discussing the issue at all, they should vote "no" on the ballot.

Paper ballots were collected from members of the Board (each "joint member" such as married couples only got one vote). The resolution passed on a vote of 19 to 6, with one abstention. A quorum of the Board is 20 members, so this vote can be considered a Board vote.

PPERRIA COMMITTEE UPDATES

Zoning and Land Use Committee – John Wicks said that the Committee met on February 21. Its rules of procedure are "close to a resolution." A plan has been presented for development of the Huron/Washington/University site (currently occupied by Arby's). The proposal is for a student housing project of 1200 bedrooms, with 30,000 square feet of retail on the ground floor. The developers are seeking a parking variance from the required ½ off-street parking space per bedroom down to 3/10ths of a space per bedroom. A subcommittee of the Zoning Committee consisting of Dick Gilyard, Clay Lambert, Dick Brownlee and John Wicks has been formed to look at this proposed project. The Profile Center has applied for a "Class B" liquor license (permitting live entertainment). The "maximum occupancy limits" for single-family houses will be discussed at a meeting with Cam Gordon next month. Dick G. expressed an interest in forming a Housing Committee.

Historic District Committee – Joe Ring said that Charlene Roise of Hess Roise and Co. has prepared a chart comparing Prospect Park to several other neighborhoods in Minneapolis. Cam Gordon said he met with Diane Hofstede (Ward 3) and is convinced that the city does have the authority to create conservation districts but that doing so is "going to be a long process."

Master Plan and Transit Committee – Dick Gilyard said that the three types of parking crucial to the neighborhood are residential, commercial and University-related. Prospect Park 2020 is seeking ongoing funding. The American Craft Council is considering relocating to this area.

Organizational Development Committee – Dick P. said the committee is trying to build up a "reserve fund" of money that could be used by PPERRIA to address issues as they arise. For example, if PPERRIA had such a fund, a sound engineer could be hired to address the sound wall issue.

NEW BUSINESS

The PPERRIA Annual Meeting will be held April 23 in the Profile Center. Dick P. is seeking volunteers to organize this event.

The meeting was adjourned at 9:15 PM.
