### Notes from the president

Elcome, to the newly elected PPERRIA directors, and especially to those serving for the first time. At the Annual meeting on April 28th, 20 PPERRIA members were elected to 2-year terms on the Board of Directors and 10 of those are new members of the board. Another new member was elected to fill a vacant slot for a one-year term. Regular attendance at the monthly board meetings is important and I hope this influx of new board members brings a renewed interest in participation.

Just as we have examined the PPERRIA bylaws and debated its provisions, we should also examine the purposes of PPERRIA. Here is the bylaws Statement of Purpose: "To promote, in a non-partisan, educational and cooperative manner, the health, safety and general welfare of its residents and to promote the maintenance and improvement of the aesthetic, residential and physical qualities of the environment." In other words, one purpose is to preserve and improve the amenities that make Prospect Park a great place in which to live.

What are those amenities exactly? And how do we maintain them while the world around us changes and evolves? Mostly we have dealt with this by shielding the neighborhood from the outside. We have focused on its architectural and historical character through National Historical designation and we have opposed encroachment from industry and from the University of Minnesota.

With increasing pressures to change, we need a clear understanding of what makes our community special and desirable, so we can hold on to it as we adapt to the changes. Maintaining the status quo is not an option. Because there are already pressures on many fronts, It is critical for PPERRIA to achieve a common vision and plan for our

neighborhood. This will position us to seek ways to engage with the forces of development, thus improving the odds of achieving our purpose.

In developing a master plan we need to examine how PPERRIA can carry out its purpose by identifying:

- What we need to preserve and maintain and,
- What and where we can encourage what's new.

We have done this before. The NRP process in 1993-1995 was perhaps the most recent and comprehensive attempt to develop a neighborhood plan. Through that process we identified Pratt as an essential element for the community – as a school, a community center, and a community education facility. More recently, in 2004-2005, we developed a plan and a design criteria for SE University Avenue, and for the 29<sup>th</sup> Avenue Light Rail station. The latter was adopted by the city as a part of the Minneapolis Plan and it has provided a guide for proposed development. These two plans remain as valid guidelines for us, but they need to be updated to address the changing make-up of the neighborhood and our changing environment.

This year we will add a new Standing Committee for Planning. This committee will continue the efforts started by the Zoning Committee to become more pro-active in dealing with zoning and landuse issues. The charge to the new committee will be to develop a master plan for our neighborhood. Such a plan will guide the decisions and actions that promote the maintenance and improvement of the aesthetic, residential and physical qualities of the Prospect Park neighborhood environment.

# Minutes of PPERRIA Annual Membership and Board of Directors Meeting Monday, April 28th, 2008, 7 pm, Prospect Park United Methodist Church

President Dick Poppele called the Annual Meeting to order at 7:05 p.m. President Poppele welcomed visitors and new members.

- 1. Claudia Fuentes of the City of Minneapolis announced that the Prospect Park Water Tower would be open to visitors at 4:00 p.m. on May 30 (Pratt Ice Cream Social). Claudia is also a Pratt School parent, and announced the Silent Auction that will be happening at the Ice Cream Social, and requested donations for the event.
- **2. Agenda:** A motion to approve the amended agenda was made by Andy Mickel. Passed without noes.
- 3. Election: Gratia Reynolds, chair of the nominating committee, presented the slate of candidates nominated for the Board of Directors. The slate consisted of 23 members to fill 21 Board positions and 2 alternates. Each candidate was asked to introduce him/herself and present two of their goals for the organization. No nominations were made from the floor. The members proceeded to vote.
- 4. University Partnership Alliance: Dick Poppele, Cam Gordon and Jan Morlock presented the history and progress of the Alliance. When the Legislature funded the University of Minnesota Stadium they required a report on the impact of the University on the surrounding neighborhoods. "Moving Forward Together" was drafted by the Stadium Advisory Group (SAG) after which the Legislature allocated \$750,000 to SAG, which became the University Partnership Alliance, with members from the University, the City of Minneapolis, the neighborhoods and business groups from Cedar Riverside, Marcy-Holmes, Como, Prospect Park and the University District. The goal of the group was mandated by the legislature to promote the area as a place to "study, research and live." The Alliance set goals to maintain and preserve home ownership in the area, and to reverse
- the trend of conversion of single-family owneroccupied homes to rental property, to promote the area as a place to do business, live and learn, and to demonstrate functioning cooperatively as an alliance of stakeholders. A Power Point Presentation described the organization and functioning of the Alliance to date. Committees were established to set short- and long-term goals and tasks. A demonstration project was designed to encourage the maintenance of owneroccupied housing in the neighborhoods surrounding the University – with a first step being to identify areas where such housing was most threatened – and set up a program attempting to gain a right of first-refusal if a property was offered for sale. This would allow the Alliance to market the property to owner-occupants. The Como neighborhood was selected as the most threatened, and thus the pilot area for the demonstration project. Another facet of the program will be to assist homebuyers to acquire property.
- **5. Ralph Rapson:** Tribute was paid to Ralph Rapson, long time Prospect Park neighbor. and noted architect. Florence Littman spoke of Ralph's many gifts to the community, and of his support in helping to maintain the character and quality of development in the area. Jane Starr spoke of Ralph's participation in the addition to her home, while his son Toby was the architect. Betts Zerby introduced the subject of a memorial from PPERRIA to Ralph, and offered a resolution to have the park at Tower Hill named after Rapson. The resolution failed. Paul Zerby moved that further consideration be made to an appropriate memorial to be established. Motion passed.

- **6. Bikeway:** Andy Mickel reported that the Committee to find a way to continue the Grand Rounds bikeway had determined that the bikeway would travel on 27<sup>th</sup> Avenue SE and the proposed Granary Road through the Como area. A final report has been prepared, which Andy will e-mail to those who request it.
- 7. Flowers: As usual, flowers were available for all to take home. Special gifts of flowers were made to long-time Board members who are retiring from the board: Tom Kilton, and Susan Larson-Fleming were presented with large geraniums, and Committee Chairs were given other perennials.
