#### PPERRIA Annual Meeting Minutes April 23, 2012, Profile Event Center, University Avenue SE

Members arrived at 6:30 or later for refreshments, conversation, and viewing exhibits of recent goings-on in Prospect Park. The Annual Meeting was called to order at 7:07 pm by President Dick Poppele. He welcomed all members and guests and thanked Patrick Kellis, the manager of Profile Center, for providing the wonderful meeting space and the food and drink.

The agenda was approved. The minutes of the March meeting, printed in the newsletter, will be discussed at the May meeting. A quorum of the Board of Directors was present.

#### **ANNOUNCEMENTS**

John Orrison of the **Community Concerts Committee** announced that concerts will be held at the Pratt Amphitheater at 7:30 PM on June 12 (Dean Magraw) and July 17 (Light of the Moon). A third concert may be held on August 14, but no performer(s) has (have) been booked for that evening. In case of rain, the concerts will be held indoor at Prospect Park United Methodist Church.

Phil Anderson, the Prospect Park representative of the **District Councils Collaborative**, said that on May 6 the DCC hopes to attract volunteers to take a "walkability survey." Volunteers will walk to each LRT station in or near Prospect Park (the 29th Avenue station and the Westgate station), in groups, discussing things they see along the route which might impact the ability of pedestrians to get to the station. The "walkability survey" will help to set priorities for making improvements to walking routes to the stations.

#### REPORT OF THE NOMINATING COMMITTEE

Richard Adams of the Nominating Committee announced the slate of candidates for the Board of Directors. Candidates introduced themselves, said where they lived, how long they had lived in the Park, and why they wanted to be on the Board of Directors of PPERRIA. Richard thanked everyone who had agreed to run for the Board and said that candidates did not have to be present at this meeting in order to be elected (Judy Farmer, for example, is currently on a boat on the Amazon River).

Nominations from the floor were accepted. Steve Ficker nominated himself. Ballots were marked and collected.

#### REMARKS FROM POLITICAL OFFICE HOLDERS

Peter McLaughlin, Hennepin County Commissioner said that he had brought along maps showing major roads and bicycle trails in Hennepin County. He said that the "Boeser site" (on 4<sup>th</sup> Street north of the Overflow Coffee café) is slated for development by the Cornerstone Group. Hennepin County will consider a request from Cornerstone for a \$1 million Transit-Oriented-Development loan. All three neighborhoods in Southeast Minneapolis (Como, Marcy-Holmes and Prospect Park) are interested in getting a new library to replace the Hennepin County Library in Dinkytown. The "Prospect Park 2020" group favors construction of a new library north of University Avenue near the Prospect Park/29<sup>th</sup> Avenue station of the Light Rail Transit line. McLaughlin said the crucial question to consider in siting and stocking a library is "What should a community library look like in the 21<sup>st</sup> century?" He said that a committee from the neighborhood would be formed to plan the new Southeast Library before construction started in 2016.

Adam Dunnock, a new member of the Metropolitan Council said that the Council was hoping to coordinate bus routes with stations of the LRT. Changes in bus routes will be listed on the Met Council website.

Cam Gordon, City Council member from the 2<sup>nd</sup> Ward, praised the work of the Prospect Park 2020 group. He also praised city planner Haila Maze, who recently received the 2011 University of Minnesota Outstanding Community Service Award — Partner. This award is for service to the University and the community and recognizes the contributions Haila has made to the work of the University District Alliance.

A public hearing on the proposed new stadium for the Minnesota Vikings will be held on Tuesday, April 24 at City Hall. In answer to a question about Peavey Plaza in downtown Minneapolis, Cam said that revamping of the plaza was necessary because the pumps were not working, accessibility for handicapped people was difficult, and hidden nooks created safety issues. He said that the city Heritage Preservation Commission has concerns about the proposed changes. He said, "it's an honor and a pleasure to serve as a Council member."

Peter Wagenius, a Prospect Park resident and the policy director for Mayor R. T. Rybak, said that he has been named to a task force formed by the state legislature to look at the issue of Local Government Aid. He said that "all kinds of problems have been kicked down the road [by the legislature] but that "a reckoning is coming" if property taxes were not to explode. He praised Prospect Park for embracing the Light Rail Transit line and planning for it, saying that PP is doing "what cities all across the country wish <u>every</u> neighborhood would do."

#### Launching new "PROSPECT PARK FORWARD Investment Fund"

President Dick Poppele announced the creation of a new PPERRIA fund called "Prospect Park FORWARD." A three-year fund drive, starting at this meeting, hopes to raise \$100,000 for this fund. PP FORWARD will be a "reserve fund" to be used as the need arises. The Neighborhood Revitalization Fund has ended and it is uncertain what funds will be available from the city of Minneapolis to aid neighborhoods in the future. Dick said that having a reserve fund would give the Board of Directors "the capacity to act when we need to act" and would help " to preserve what makes our neighborhood great." As an example, the recent construction of a sound wall along I-94 has created more noise in some parts of the neighborhood. If PPERRIA could hire a sound engineer to take sound readings and prepare a case, the Minnesota Department of Transportation might be persuaded to change the configuration of the sound wall.

Joe Ring, immediate past president of PPERRIA, said that he served as president for three years. He said that, despite the volunteer labor on which the organization relies, "sometimes professional help is needed" and that PP FORWARD would enable the organization to hire paid help in an emergency.

Florence Littman, another past president of PPERRIA, also spoke in support of the new fund. She said, "No matter how right you are, how dedicated you are, or how hard you work, <u>you still need money</u>." She recalled a crisis which faced the neighborhood in the past when a cement crushing plant was proposed which would have been within 1000 feet of the houses on 4<sup>th</sup> Street. PPERRIA raised money to hire a lawyer to fight the proposal. The case went through the Court of Appeals all the way to the Minnesota Supreme Court, which ruled in favor of the neighborhood. The cement crushing plant was never built. This result would not have been so favorable had the neighborhood not been able to pay a lawyer to argue the case.

A third past president of PPERRIA, Steve Cross, that he thought the new fund was "a fund for PPERRIA's future" and "a brilliant idea that no one else has thought of."

Dick P. said that he had approached several residents before the official launching of the PP FORWARD fund. Twelve residents have pledged a total of \$10,142 dollars to the new fund and another resident has pledged a "matching grant" of \$1750 (to be paid if another \$1750 can be raised from other residents). He said this was "a tremendous vote of confidence in this neighborhood."

Donations to this fund should be made out to "PPERRIA" and sent to PPERRIA/66 Malcolm Avenue SE/Minneapolis 55414, with an indication upon the check that this money is for PROSPECT PARK FORWARD.

#### **RECESS**

A twenty-minute recess was taken to enable vote counters to tabulate the ballots for Board of Directors and to allow the rest of the people present time for looking at the various displays set up around the perimeter of the room, eating, and schmoozing. Food provided by the Profile Center included chicken satay, skewers of mozzarella and cherry tomatoes, melon slices, sambusas, cheese and crackers, and coconut shrimp.

#### PROPOSED BY-LAW CHANGES

The Executive Committee proposes the following By Law changes. This will be voted on at the June meeting. (Note that: The following does not comprise the complete By-laws, but only those portions proposed for changing. Also, strike-through text (such as this) would be deleted while <u>underlined text</u> would be added.)

In summary, the proposed changes (other than housekeeping matters) would:

- · ease membership access for both business entities and individuals
- reduce the number of the board of directors from 40 to 30
- · encourage an increased level of participation by board members generally
- reduce votes needed to approve amendments from "two-thirds," to "a majority" of all the directors

**Article II Purpose:** The purposes of the corporation are to promote, in a non-partisan, educational and cooperative manner, the health, safety and general welfare of the residents, <u>businesses and other entities</u> within the association's geographic jurisdiction and to promote the maintenance and improvement of the aesthetic, residential and physical qualities of the environment in which those residents reside.

#### **Article III Membership**

#### C. Membership

Persons shall become members from the next meeting following approval submission of the completed membership application. The committee shall have no more than 30 days to determine eligibility, grant or deny the application, and, if granted, add the name to the PPERRIA membership roster. The database manager shall add the name to the PPERRIA membership is effective through and including the next annual meeting.

#### **Article IV Directors and Officers**

#### A. Board of Directors

At the first meeting of the Corporation, In each even numbered year 20 15 members with two year terms expiring April '81 in even numbered years and in each odd numbered year 20 15 members with two year terms expiring in odd numbered years April '82 will be elected. Thereafter, at each Annual Meeting, the Corporation shall elect (15) of its members to serve for a two-year term as Directors of the Corporation. At any time there shall be forty thirty (30) Directors of the Corporation. All directors must reside within the boundaries of PPERRIA.

To ensure effective participation, two persons from the same household may be jointly elected to serve as one Director. Directors shall:

Make a good faith effort to attend all regular meetings of the corporation and

Participate actively in the conduct of Corporation business during their two-year term, which begins with the first Board of Directors meeting after the Annual Meeting.

<u>Directors shall:</u>

- Make a good faith effort to attend all regular meetings of the corporation and
- Participate actively in the conduct of Corporation business during their two-year term, which begins with the first Board of Directors meeting after the Annual Meeting.

#### D. Nominating Committee

At the general meeting of the Corporation held in January three months prior to the Annual Meeting, the President shall appoint a Nominating Committee Chairperson.

#### **Article V Meetings**

A. Annual Meetings

The Annual Meetings of the Corporation members shall be held during the month of April on a date fixed by the Executive Committee. .

D. Votina

The result of any unanimous vote at a regular or special membership meeting is conclusively presumed to be that of the Board of Directors. Any non-unanimous vote of the membership regarding the business and affairs of the

corporation shall be advisory to the Board and a separate vote of the Board shall be taken and recorded as the	ìе
position of the corporation, unless the votes for or against a proposal are made only by non-board members,	in
which case the presumption that the Board has acted remains.

#### To neighborhood activist Jim Widder

I am honored to recognize Jim Widder for his outstanding contribution to the Prospect Park neighborhood. He helped to reconvene the Luxton Park Council along with a Glendale Resident, Marnette Gordon, and John Outlaw the Park Director. As an urban pioneer, Jim knew how to rebuild and continue his dedication over the past 20 years. It is now seven park directors later, the landscape has changed but the charge to give kids direction in life and be part of a team and a community has not changed. He has made the park a meeting place between neighborhoods of Glendale Town Homes, Tower Hill and East River Road kids and neighbors. Besides his active role leading the Luxton Council Jim also coached several girls' softball teams, volunteered to work with kids to build and launch rockets and taught a class for Summer Splash called 'Things that Fly'. Jim made Halloween a very special event with his famous Haunted House. The planning and implementing was done with the involvement of many children representing our diverse neighborhood. In 1995 the height of the NRP initiative gave birth to the Fire and Ice Festival using Jim's beautiful sketch advertising this memorable event. Jim has continued to enlist Draft horses to lead a hayride around the neighborhood, arrange snow sculpture exhibits done by the kids, and secure jazz band music along with Jean Emmons' famous chili and chocolate desserts. Jim's architectural firm, Archithesis, was selected to design the Pratt school grounds and Village Green which includes a grand civic arbor, a performance amphitheatre, and a playground for children. It also serves as the site of the Pratt Ice Cream Social. He leaves a legacy which will long be remembered and deeply appreciated.

#### Surviving construction

The good news? – No cars, bikes or pedestrians have been lost in the depths of University Avenue's construction trenches. With work on the north side starting its last phase, the deep digging to reach antiquated sewers is almost done. Work is now preparing for the all-new street surfaces, curbs, and sidewalks.

The bad news? – Navigating is problematic (but it can pay off in supporting our local businesses).

How to tell what accesses are open or closed? – Read the weekly *Construction Update* from the Central Corridor LRT. It's posted every Friday to the ppe-list. (Or get it sent directly to your own e-mail.) Also, updates are available on the web so you can quickly check before heading out, or use your cell phone. These include all the construction areas in Minneapolis (Prospect Park is at the tail end). The LRT contractor has to maintain continual access to all residences and businesses. Signage generally directs traffic, but with so many signs, it's easy to miss the one you need most! Pedestrians may cross at all signaled intersections, but need to follow detours through "cattle chute" fences (follow the little pedestrian detour arrows). The LRT office and contractors make every effort to give notice before closing streets or sidewalks. Alerts from utility contractors have been less dependable, and occasionally we're surprised by a sudden closure. Detours are marked, but this summer will be an exercise in patience!

There is always a way into a local business. The official orange "Business Access" signs are generic – but many locals are adding creative touches: A sandwich board in front of Schneider Drug says there's parking in back; Spire Federal Credit Union has a big sign on their building; Overflow Espresso Café has their "Follow the Yellow Brick Road" trail. Overflow reports business down 30% and getting worse; construction of the Prospect Park Station will keep 29<sup>th</sup> Avenue closed all summer. Overflow's sidewalk access is complicated but possible, and parking in back is reached via Malcolm Avenue and 4<sup>th</sup> Street.

The CCLTR office and the Metropolitan Council offer businesses help during construction. One of the simplest is customized maps on the business web site or Facebook page, created by LRT staff and updated as necessary. Other aid for surviving construction includes forgivable loans and inclusion in the *Discover Central Corridor* marketing efforts. These can be found at <a href="http://www.readyforrail.net/">http://www.readyforrail.net/</a> A Weekly Update features a specific business somewhere along the route. Several in Prospect Park have been featured so far.

Coming in mid-to-late-May is the opening of the Bedford intersection north of University, followed by a traffic switch to the north lanes of the avenue, probably late in June.

#### **Guest editorial**

The following is a concise strategy for helping one, among the many, struggling businesses along University Avenue to survive economically through the LRT construction period. We hope others will come forth, and this is to encourage more to follow. We will happily identify them as they do.

#### One barber shop at a time

Pete's shop is one door east of Tom's drug store on University. We're establishing what could be called the Pete LeBak Bridge Marketing Fund. Its purpose is to support a marketing campaign to help barber Pete LeBak survive the construction period until the LRT is operating regularly on University Avenue. It requires things Pete has never had to do before – reaching out to every potential customer he can identify. It'll need serious marketing help if Pete's inimitable style of barbershop is to survive the challenge.

We're talking flyers, cards, handouts, door-hangers, etc. Asking this from volunteers alone is not feasible. We need a modest reserve fund to cover design, printing, maybe even distribution costs. (Summer jobs for local kids?)

One suggestion was a "Hard Hat Special," for which Pete has already had cards printed. It's aimed at the on-site construction worker. The "special" part is Pete's offer of after-hours haircuts, by appointment. Additional suggestions have come in, but they all cost something to act on, and these are lean times at Pete LeBak's Barber Shop.
